3. The remaining balance will be billed in 9 monthly installments due each month from Sept. 2010 through May 2011.
4. A late fee of \$50/month will be assessed for any overdue balance after the tenth of the month.
5. An option to pay the full-year tuition is available at a 3% discount (Sept. 15, 2010 deadline)
6. Visa and Master Cards are accepted.
- 7. Refunds can only be made if you move from Sonoma County.**
8. A fee of \$50 will be assessed for all returned checks.
9. Any modification of these terms must be in writing, signed by both parties.
