5. An option to pay the full-year tuition is available at a 3% discount (Sept. 15, 2010 deadline)
6. Visa and Master Cards are accepted.
7. **Refunds can only be made if you move from Sonoma County.**
8. A fee of \$50 will be assessed for all returned checks.
9. **Any modification of these terms must be in writing, signed by both parties.**
